#### THANKS Contest

#### 1. CONTEST ORGANIZER

The *THANKS* contest is organized by Beneva Inc. ("Beneva" or the "Contest Organizer")

## 2. CONTEST PERIOD

The contest will be held in Quebec from 12:00 a.m. ET on January 10, 2022, to 11:59 p.m. ET on January 8, 2023 ("Contest Period").

## 3. ELIGIBILITY CONDITIONS

To enter this contest, participants must:

- Be a resident of the province of Quebec
- Be age 18 or over on January 8, 2023
- On January 8, 2023, hold an eligible insurance product from La Capitale General Insurance Inc. or Beneva.

## 4. HOW TO ENTER
