Should the market index or underlying fund be unavailable or cease to be used by the Insurer for any reason whatsoever, the Insurer reserves the right to replace it with another market index or underlying fund it deems equivalent or to determine the applicable rate of return.

Transaction date: Except under certain circumstances, the transaction date for a purchase or redemption shall be the business day on which the form is received at the Insurer's office, provided that it is completed in full, duly signed and submitted with any required amounts. The Insurer reserves the right to change the transaction date without notice.

It should be noted that amounts invested in Canadian Equity Index and American Equity Index accounts will, without exception, be processed on the business day following their receipt.

Redemption and transfer fees: This investment may be redeemed or transferred at any time, subject to transfer and redemption fees, as applicable.
