The management expense ratio (MER) is an estimation and includes management and administration fees as well as the taxes. It is calculated as a percentage of the fund's net assets. This ratio may vary from one year to the next. Guarantee fees are added to the MER.
- 2. Guarantee fees are calculated as a percentage of the fund's net assets, except for Beneva Guaranteed Income 2 and Beneva Guaranteed Income 2.1 contracts. Beneva Guaranteed Income 2 and Beneva Guaranteed Income 2.1 guarantee fees are calculated as a percentage of Guaranteed Withdrawal Balance, except for Beneva Fiera Capital Money Market GIF and Beneva Fiera Capital Short Term Bond GIF fees, which are calculated as a percentage of the fund's net assets.
- Beneva Guaranteed Income product: This fund is eligible for the Beneva Guaranteed Income product, but does not include the guaranteed minimum withdrawal benefit (GMWB).
- 4. 20% of the portfolio is subject to an additional 20% performance fee on returns exceeding the benchmark index.
- One third of the portfolio is subject to an additional 10% performance fee on returns exceeding the benchmark index.
