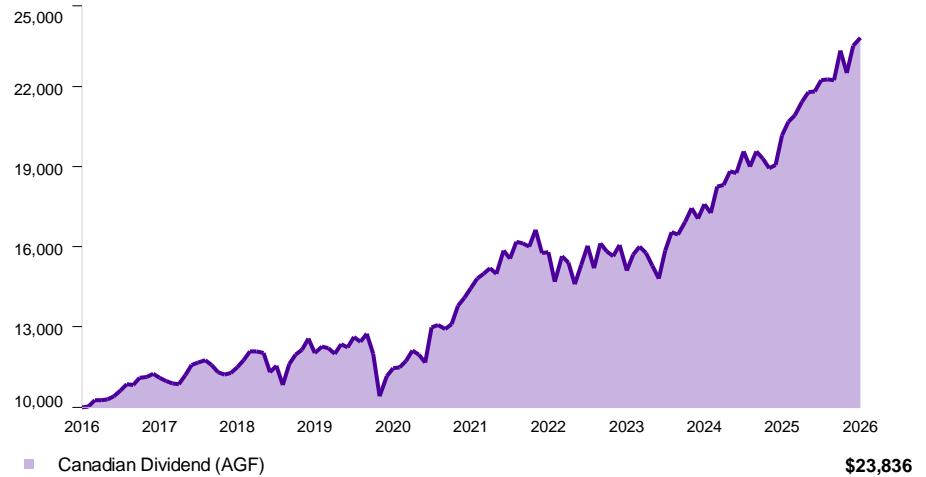

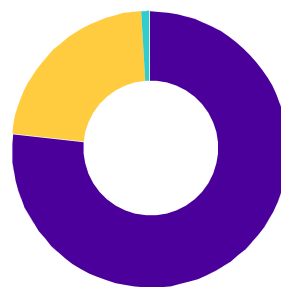

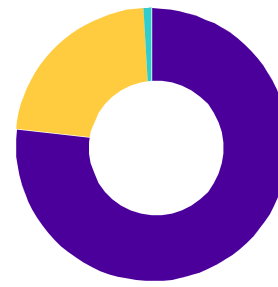


**Allocations: March 31, 2026**

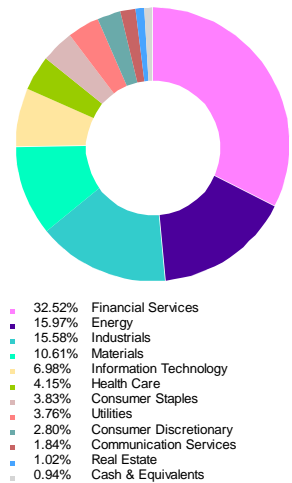
Asset Allocation
