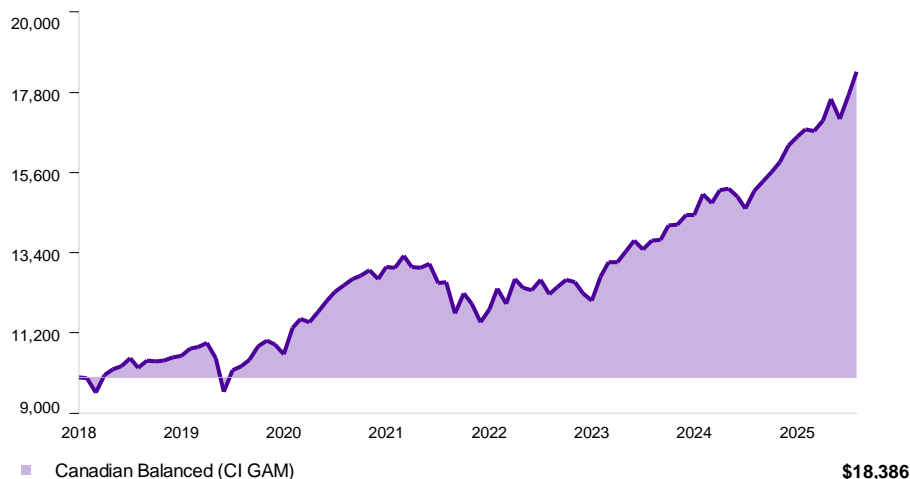

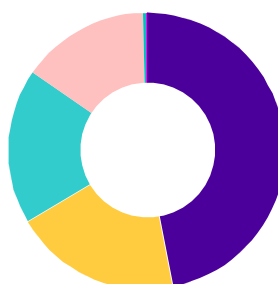

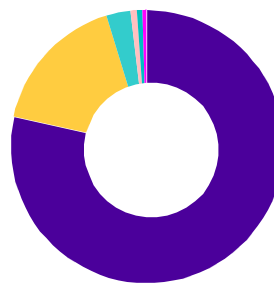


## Allocations: March 31, 2026

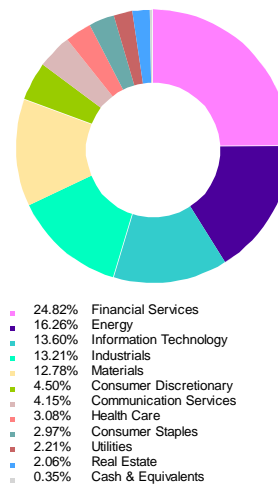
Asset Allocation
