Important: To partition accrued benefits, the ex-spouses must sign a written agreement within 12 months after the end of your conjugal relationship. If this time period has already expired, it doesn't serve any purpose to apply for a statement for signing an agreement.

The application can be signed jointly or otherwise. However, regardless of who makes the application, two copies of the statement will be issued and one copy will be sent to the plan member and the other to the spouse.
