Saving is Winning!

Contests Organizer

The Saving is Winning! contest is held and organized by Beneva Inc. ("Beneva" or the "Organizer").

2. Contests Period

Gift Cards: The contest runs in Québec from December 1, 2025, at 12:00 a.m. (ET) to January 31, 2026, at 11:59 p.m. (ET).

\$2,500 Draws: The contest runs in Québec from December 1, 2025, at 12:00 a.m. (ET) to March 2, 2026, at 11:59 p.m. (ET).

The contests duration are hereinafter referred to as the "Contests Periods."

3. Eligibility Conditions

To be eligible for the contests, a person must:

- Be a resident of the province of Quebec
- Be at least 18 years old by February 13, 2026 for the grocery gift cards and by March 16, 2026 for the \$2,500 prizes draws

4. How do you enter?

Participation in these contests are free, with no purchase necessary. Each participant is eligible to a maximum of two entries in total, regardless of the chosen methods of participation (contributions and/or texts).

To enter these contests, participants must satisfy the eligibility conditions and the other conditions set out in these contests rules.

Subject to the limitations contained herein, there are two (2) ways to enter during the Contests Periods:

4.1 Contribute to your RRSP or TFSA

To enter, the Participant must contribute to an existing Beneva RRSP or TFSA account, or open one, by completing the following transaction:

 Make a contribution via a one-time or automatic withdrawal to their RRSP or TFSA account during the Contests Periods.

Participation limit: Each Participant is eligible for all draws held after the date of their contribution to a Beneva RRSP or TFSA account.

If a Participant makes contributions to both an RRSP and a TFSA account during the Contests Periods, they will receive two entries—one for each account type.

If a Participant makes multiple contributions (automatic or one-time) to the same RRSP or TFSA account during the Contests Periods, they will receive only one entry for that account.

4.2 Alternative method of entry: No purchase or consideration required.

You may also enter these Contests without making any purchase by mailing a sheet of white paper indicating your first name, last name, phone number, and complete mailing address (including postal code), along with a unique and original 500-word text on one of the following topics: "The importance of saving early for retirement" and/or "The advantages of a TFSA in achieving financial goals". 5. Prize details

Entering these contests give the participant a chance to win one or these following prizes:

First prize: One of three (3) grocery gift cards worth \$1,000 each, at a store of your choice

Second prize: 2 prizes of \$2,500 each

6. Specific prize conditions

The prizes cannot be redeemed for cash, transferred, assigned or exchanged.

7. Draw

7.1 Date and location

For the three (3) gift cards, the draws will take place on February 13, 2026, at 3:00 p.m. (ET) in the presence of a witness from Beneva employees, at Beneva's offices located at 625 Jacques-Parizeau Street, Québec (Québec), G1K 9E2.

For the two (2) \$2,500 prizes, the draws will take place on March 16, 2026, at 3:00 p.m. (ET) in the presence of a witness from Beneva employees, at Beneva's offices located at 625 Jacques-Parizeau Street, Québec (Québec), G1K 9E2.

7.2 Odds of winning

The odds of winning depend on the number of eligible entries received during the Contests Periods.

7.3 Disqualification or cancellation

Beneva reserves the right to disqualify persons or cancel entries that are not in compliance with these contests rules.

8. Participation limitations and exclusions

8.1 Number of entries

The number of participations per person is limited in accordance with the provisions under section 4 of these contests rules.

8.2 Participant exclusion

Employees, mandataries, officers, administrators and representatives of Beneva Inc. and its affiliated companies, and individuals residing at the same address, may not enter these contests.

Also excluded from entering the contests are representatives, agents, firms and agencies attached or affiliated with Beneva Inc. and its affiliated companies as well as their employees and the persons with whom they are domiciled.

9. General conditions

To be declared a winner, the entrants must be randomly selected and meet the following conditions:

- Answer the phone call from the Organizer to be informed of the prize delivery terms within ten (10) business days following the draw. The selected person must be reached within a maximum of three (3) attempts and will have ten (10) business days to return the Organizer's call after a voicemail message has been left, if applicable; otherwise, they will forfeit their right to the prize.
- Confirm that they meet the eligibility conditions and other requirements of these contests rules.
- Correctly answer, without assistance and within a limited time, a mathematical skill-testing question.

The prize must be accepted as described in these contests rules and is not, in any case, transferable in whole or in part to another person, unless otherwise indicated, if applicable.

9.4 Limitation of liability – Use of the prize

The prize winner releases the Organizer, its advertising and promotional agencies and their employees, agents and representatives from any potential damage, harm or loss resulting from their acceptance or use of the prize.

All participants selected acknowledge that, as of their being informed of the prize delivery arrangements, the fulfilment of the obligations related to the prize becomes the entire and exclusive responsibility of the various service and product providers.

9.5 Limitation of liability – Contests operation

The Organizer, its advertising and promotional agencies, its affiliated companies, their employees, agents and representatives are not liable for any technological malfunctions that limit or make it impossible to enter the contests.

This includes any faulty computer components, software or lines of communication, the loss or absence of network communication capability, or any faulty, incomplete, incomprehensible or deleted transmissions by any computer or network.

9.6 Limitation of liability - Registration
