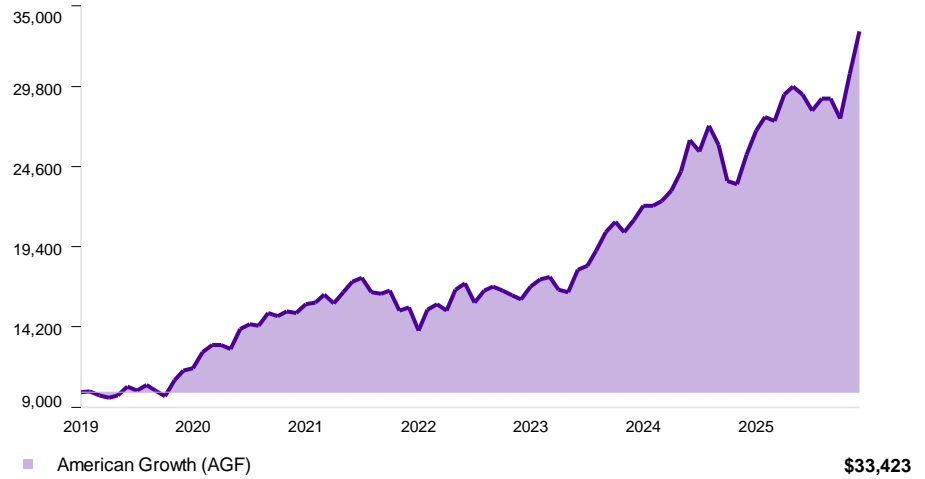

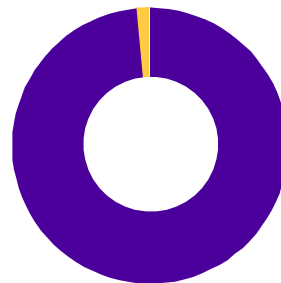

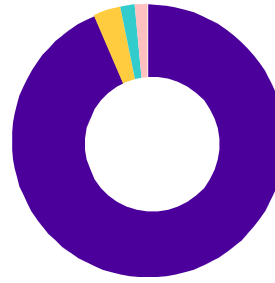

**Asset Allocation**



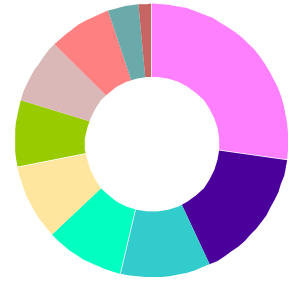
